ATTEMPTED MURDER

On September 4th, 2021 Hampton County Sheriff's Office Deputies were dispatched to Old Salkehatchie Highway in the Varnville area of Hampton County in reference to a shooting incident. While enroute Deputies learned the victim, later identified as Alex Murdaugh, had been shot in the head, and was being flown out from a landing zone on Charleston Highway (Varnville) to the hospital. Corporal Henderson met with the victim before he was flown out, while I, Sergeant White, secured the scene of the crime until HCSO and SLED investigators arrived. Further investigation required.
