Received is the body of a well-developed, well-nourished female child appearing compatible with the reported age. The body is clad in shirt, shorts, underwear and socks. Nothing accompanies the body. There are no readily identifiable marks or scars. There is no evidence of medical intervention.

INJURIES

External Examination

There is dirt across the body. Decomposition changes are manifested by a green discoloration of the abdomen. The

body is received with the shorts and underwear partially pulled down over the upper thighs. The underwear are fluid stained.

There is pressure blanching at the left forehead. There is postmortem drying at the nose. At the posterior left scalp is an area of contusion and soft tissue swelling covering an area of 6" x 5". There is a $\frac{1}{2}$ " abrasion at the posterior aspect of the right helix. There are abrasions at the upper and lower lips that range in size from $\frac{1}{8}$ " to $\frac{1}{4}$ ". There is $\frac{1}{2}$ " contusion at the chin. There is a linear abrasion at the left chin.

On the anterior chest and abdomen at least ten contusions are identified. These range in size from $\frac{1}{4}$ " to $\frac{1}{2}$ ". There is a $\frac{1}{4}$ " abrasion lateral to the right nipple and linear abrasion at the left lower quadrant of the abdomen.

At least six contusions involve the right arm and hand. These range in size from 1/4" to 3/4".

At least fourteen contusions involve the left arm and hand. These range in size from 1/4" to 13/4".

There is a linear abrasion on the right back. At least four contusions are identified on the posterior abdomen and buttocks. These range in size from $\frac{1}{4}$ " to 1".

There is healing linear abrasion on the right thigh.

There are at least eleven contusions identified on the right leg and foot including involvement of the plantar surface of the right foot. These range in size from $\frac{1}{4}$ " to $\frac{13}{4}$ ".

At least fifteen contusions are identified on the left leg and foot including the plantar surface of the left foot. These range in size from 1/4" to 3". There is an abrasion on the top of the left foot.

There is a 1½" ecchymosis around the anus with relative sparing at the 12 o'clock and 6 o'clock position. This may represent postmortem change. Definitive abrasion and laceration is not identified.

Internal Examination

Reflection of the scalp reveals an area of subgaleal hemorrhage overlying the right frontal/parietal region of the skull that extends to 2½". There is an area of subgaleal hemorrhage overlying the left temporal/occipital region extending to 5". There is thick overlying scalp hematoma at this location.

Reflection of the skin at the anterior chest and abdomen reveals numerous soft tissue ecchymoses. There is extensive soft tissue hemorrhage at the bilateral inguinal region.

Upon opening the body cavities, liquid blood spills from the abdominal cavity. Approximately 300 cc of liquid blood is collected. A 2.5" mesenteric laceration is identified at the small bowel and right colon mesentery. There is extensive retroperitoneal hemorrhage predominantly at the right. There is a laceration of the pancreas at mid body.

PROCEDURES

Radiographs

Whole body radiographs do not reveal any osseous abnormalities.

INTERNAL EXAMINATION

Body Cavities

The bilateral pleural cavities are free of significant fluid and adhesions. The organs are in their normal anatomic positions.

Cardiovascular System

Heart Weight 60 grams

The pericardial sac is free of significant fluid and adhesions. The coronary arteries arise normally, follow the usual distribution and are widely patent. The chambers and valves bear the usual size-position relationships and are unremarkable. The myocardium shows no evidence of acute infarction, scarring or focal lesions. The aorta and its major branches are intact without significant atherosclerosis.

Respiratory System

Right Lung Weight 80 grams **Left Lung Weight** 70 grams

Examination of the soft tissues of the neck including the strap muscles and large vessels reveals no abnormalities. The hyoid bone and laryngeal cartilages are intact. The larynx is clear. The lingual mucosa is intact; the underlying musculature is devoid of hemorrhage. The upper and lower airways are free of debris and foreign material. The lungs are normally formed. The parenchyma of both lungs shows moderate congestion without obvious consolidation or focal lesions. The pulmonary arteries are free of thrombi or emboli.

Gastrointestinal System

Except as previously noted, grossly unremarkable. The stomach contains 20 ml of yellow/white partially digested food.

Liver

Liver Weight 360 grams

The capsule is intact and the parenchyma is unremarkable. The gallbladder contains bile. The extrahepatic biliary tree is patent.

Spleen

Spleen Weight 30 grams

The spleen is normally formed; no focal lesions are present.

Pancreas

Except as previously noted, grossly unremarkable.

Urinary

Right Kidney Weight 30 grams **Left Kidney Weight** 30 grams

The kidneys are of normal size and shape. The capsules strip with ease from the underlying smooth cortical surfaces. The renal architecture is intact without focal lesions. The bladder is empty.

Reproductive

Grossly unremarkable.

Endocrine

The thyroid gland and bilateral adrenal glands are grossly unremarkable.

Neurologic

Brain Weight 1241 grams

Reflection of the scalp reveals the previously described injuries. There are no skull fractures identified. The leptomeninges are thin, delicate and congested. The cerebral hemispheres are unremarkable. The vasculature at the base of the brain is intact without significant atherosclerosis. Coronal sections reveal normal architecture without focal lesions.

Skin

Except as previously noted, grossly unremarkable.

Immunologic System

Grossly unremarkable.

Musculoskeletal System

Except as previously noted, grossly unremarkable.

MICROSCOPIC EXAMINATION

Microscopic Comment

Histologic examination is not performed.

SUMMARY AND INTERPRETATION

The decedent was a 3-year-old child who was initially reported missing from her home and was later found outdoors covered with vegetation.

Autopsy examination reveals numerous blunt force injuries.

Toxicology studies are non-contributory.


Based on the history and autopsy findings, it is my opinion that the cause of death in this case is blunt force injuries.
